



Attention coaches with registered Level 7 gymnasts in the 2018 Judges Cup held at Victors Gymnastics - November 16th-18th. NAWGJ-NYN **will be** sponsoring a Level 7 NY-North gymnastics team to the National Judges Cup held in Overland Park, Kansas; January 4-6, 2019. The official and prestigious Level 7 State Team Challenge will be held in conjunction with the annual National Judges Cup Gymnastics Championships on Saturday of the competition during the last two sessions of the day.

Below are the qualifying procedures to the National Judges Cup for both the athletes and the coaches. **Please review the following details very carefully**, as most of the paperwork needs to be completed immediately following, if not before the NY-N Judges Cup Level 7 competition. Athlete Qualification Procedures:

#1) Only the top **six** (6) AA scores among all Level 7 competitors regardless of age will qualify.

#2) Minimum **36.00 AA** or above.

#3) Athletes must commit to attending the National Judges Cup **immediately following competition**.

#4) Qualifying athletes will be recognized **immediately following competition**.

#5) A check made out to NAWGJ-NYN in the amount of \$95 per qualifying athlete must be submitted **immediately following competition**.

#6) Athletes must turn in the Athlete Bio Form **immediately following competition**. (Form attached)

#7) Athletes must provide a photo to be included in the National Judges Cup Program **immediately following competition**. (jpg format only please)

#8) **Please Note:** Only qualifying athletes that turn in all paperwork, picture and payment immediately following the competition will be measured for athletic attire.

Coaches Procedures:

#1) Please discuss the above qualification procedures **BEFORE** the Judges Cup with **EVERY** Level 7 athlete you have registered.

#2) We have decided to limit the qualifying athletes to only the **six** (6) top AA athletes among all competitors regardless of age. Alternates will not be used.

#3) **Please Note:** Only athletes that turn in all paperwork, picture and provide payment immediately following the competition will be measured for athletic attire. It will be the coaches responsibility to make sure your athletes and parents understand this prior to the conclusion of the Level 7 competition at the NY Judges Cup.

#4) **Team Competition Format at National Judges Cup:** Qualifying athletes will compete for team **NY-N** but will be divided into **two** (2) groups (done by NJC), consisting of **three** (3) athletes in each group for the competition at the National Judges Cup. Each group of **three** (3) athletes compete in a different "gym" at a different time judged by different judges. This process is done to keep the integrity of the Team results. It will be your responsibility to make sure you have enough coaches on hand for this format.

#5) Due to time constraints for the custom apparel, all athletes attire will be shipped to the participating club with the most qualifying athletes. That club will be designated to make arrangements with the other qualifying athletes for the **pick up and distribution of the attire at the National Judges Cup.**

#6) NAWGJ-NYN will pay the team registration fee for entry into the Level 7 Team Competition.

#7) Please have all qualifying gymnasts' USAG # & birthdates available immediately following competition. (needed for registration into the team competition)
