I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the Activity. I fully understand that this Activity involves risks of serious bodily injury, including, but not limited to, permanent disability, paralysis and death, which may be caused by my own actions or inactions, the actions or inactions of others participating in the event, the conditions in which the event takes place, or the negligence of the "Releasees" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for any and all losses, liabilities, cost and damages that I may incur as a result of my participation in the Activity. I hereby release, discharge, and covenant not to sue The Gymnastics Academy of Atlanta, its respective administrators, directors, agents, officers, volunteers and employees, other participants, any sponsors, advertisers, and, if applicable, owners, and lessors of premises on which the Activity takes place (each considered one of the "RELEASEES" herein), from any and all liabilities, claims, demands, losses, or damages, on my account caused or alleged to be caused, in whole or in part, by the negligence of the "Releasees" or otherwise, including negligent rescue operations, and further agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any and all loss, liability, damage, or cost, which they may incur as the result of any such claim. I have read the RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, understand that I have given up substantial rights by signing it and have signed it knowingly, voluntarily and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect. PARENTAL CONSENT AND I, the Minor's parent and/or legal guardian, understand the nature of the above-referenced Activity, and the Minor's experience and capabilities and believe the Minor to be qualified to participate in such Activity. **COVID-19 POLICY:** Covid-19, Coronavirus, SARS-CoV-2 Warranty of Guardian and Visitor Responsibility and Waiver of Liability As the legal guardian of my student(s), I hereby acknowledge the Covid-19, Coronavirus, SARS-CoV-2 pandemic and any mutation thereof ("hereinafter "Covid-19"). I understand that the virus is highly contagious and that individuals carrying the virus may exhibit no symptoms, making detection of carriers impossible. I hereby consent to my student(s) participating in this program at The Gymnastics Academy of Atlanta at its facility at 2995 Cobb Pkwy NW, Kennesaw, GA 30152 ("Facility"). I further consent to my visiting the Facility. If someone else visits the facility, that person must also sign this Waiver. I further accept my responsibility to guard against the spread of Covid-19 at the Facility and I WAIVE, COVENANT NOT TO SUE and FOREVER RELEASE, The Gymnastics Academy of Atlanta affiliated and partner companies and organizations, property owners and lessors of 2995 Cobb Pkwy NW, and the staff, contractors, subcontractors, teachers and coaches of GAA and its affiliates involved in this facility program, from all liability and for any and all damages and injuries suffered by me or my student as a result of contracting Covid-19. Further, I hereby warrant and represent on behalf of myself and my student and anyone accompanying my student to the Facility the following: Neither my student, nor the persons accompanying my student, nor I have any of the following symptoms when entering the facility a. A fever above 99 degrees Fahrenheit b. Cough c. Sore throat d. Shortness of breath e. Any other symptom associated with Covid-19 6. Neither my student, nor the persons accompanying my student, nor I, nor anyone residing with any of us have traveled outside of the United States in the past thirty (30) days; 7. Neither my student, nor the persons accompanying my student, nor I have come into close contact with anyone confirmed of having the following in the past fifteen (15) days: a. Covid 19

Virus b. Influenza (any strain). I warrant and represent that if my student or the person accompanying my student or I meet any of the above listed factors, we will notify GAA and not visit the Facility for at least fourteen (14) days after the latest date upon which one of the above factors was confirmed.

**CONCUSSION POLICY:** A concussion is a brain injury that results in a temporary disruption of normal brain function. A concussion occurs when the brain is violently rocked back and forth or twisted inside the skull as a result of a blow to the head or body. Continued participation in any sport following a concussion can lead to worsening concussion symptoms, as well as increased risk for further injury to the brain, and even death. Concussion symptoms include: headache, dizziness, poor balance, moves clumsily, reduced energy levels, nausea/vomiting, blurred vision, sensitivity to light and sounds, foginess of memory, difficulty concentrating, slowed thought processes, confusion about surroundings, unexplained changes in behavior/personality and loss of consciousness. ANY ATHLETE SUSPECTED OF SUSTAINING A CONCUSSION IS NOT ALLOWED TO RETURN TO PRACTICE/COMPETITION ON THE SAME DAY OF DIAGNOSIS AND MUST BE CLEARED TO RETURN BY AN APPROPRIATE HEALTH CARE PROFESSIONAL TO PARTICIPATE IN FUTURE ACTIVITIES.

**DAY CAMPS ONLY:** The Gymnastics Academy of Atlanta's Camp Program is a sports based camp and not a licensed day care facility. GAA's program is not licensed by Bright from the Start: Georgia Department of Early Care and Learning and is not required to be licensed. Bright from the Start does not regulate or routinely inspect this program. GAA has been reviewed, and this program meets the criteria for exemption from state licensure as follows: 591-1-1-.46(b)7 (EXMT-13150). Day camp programs for children five (5) years and older that are operated between school terms, whose primary purpose is to provide organized recreational, religious, or instructional activities. The day camp programs may operate during summer and other breaks and shall operate for no more than twelve (12) hours per day. Conditions: Ages; 5-11 years Operation Months: Summer and Other School Breaks Days: Monday-Friday Hours: 8am-6pm. Exemption approval means this program is not licensed as a child care learning center and is not required to be licensed because the program operations meet the criteria described above. Therefore, the program is not required to comply with the Bright from the Start Rules for Child Care Learning Centers. Unless participating in the Childcare and Parent Services (CAPS) subsidy program, Bright from the Start will not regulate or routinely inspect this program and will only monitor the program to ensure compliance with exemption criteria and requirements or to collect data. The facility must meet all local requirements, such as complying with building, zoning and fire regulations.
